**Sample Submission**

**MINIMUM SUBMISSION:** A minimum lab fee of \$250 (excluding sampling media and equipment) and a minimum submission of 2 samples & 1 field blank apply for all routine sample submissions for quantitative analysis. Samples submitted after 3 PM will be treated as next business day submission.

**FIELD BLANKS:** One (1) field blank must be submitted in accordance to our ISO17025 accreditation requirement. If no field blank is received, CASSEN will add a blank at the expense of the client. Field Blank analysis is charged at the same rate as samples, unless otherwise stated.

**SPIKE RECOVERY (SR):** If the submitted sampling media was not provided by CASSEN or is not a type of media that CASSEN provides, the client is required to submit extra media to determine the SR. If extra media is not provided, the desorption efficiency is calculated using CASSEN media. Additional charges apply for such determination for non-routine analysis if required.

**SAMPLE DISPOSAL:** Bulk samples from clients are held for 2 weeks and will be returned to clients at their own expense after the issuance of the analytical report, unless otherwise specified by the client in writing. CASSEN's prepared samples will be discarded after reporting.

**Pricing/Payment**

**PRICING:** Analytical fees are in Canadian Dollars and do not include HST or other applicable taxes. Prices are subject to change without notice. Shipping and handling fees are not included.

**SAMPLING MEDIA:** Sampling media not submitted for analysis will be billed as per the current media pricing.

**DISCOUNT POLICY:** When more than one analyte is required for the same analysis of the same sample, a reduced rate is available for majority of the analytes. When more than 15 samples are submitted at the same time for an identical analysis, a 10 percent volume discount will be applied to the analytical fee. Please note that this volume discount does not apply to all packages and parameters, contact CASSEN for analyte-specific discounts.

**SURCHARGE FOR INTENDED LITIGATION PROJECTS:** Please note that if the results of this analysis are intended for use in any form of litigation, whether civil or criminal, that this fact shall be disclosed to our laboratory prior to any analysis being conducted, and further, there will be an additional cost related to precautionary measures required for the control of documentation and the secure storage of such samples during the testing process. Please call the lab for additional cost.

**PAYMENT POLICY:** For new clients, credit card information should be submitted before the analysis of the first work order. Payment terms are net 30 days for invoices with a purchase order. CASSEN reserves the right to apply a monthly charge of 1.5% of the unpaid balance after 30 days. Payment by either VISA or MasterCard is accepted. Some analyses require a three (3) sample minimum fee to cover the cost of method setup. A minimum lab fee of \$250 applies.

**DATA RETENTION:** Raw data, such as chromatograms and instrument printouts, are retained for three years after issuance of the report. Laboratory reports are retained for five years unless otherwise specified by client in writing.

**TURNAROUND TIME (TAT):** It is CASSEN's objective to meet the TAT requirements of our clients. Normal TAT is 5 business days for routine analysis. - Minimum submission is 2 samples and 1 field blank for all routine samples requiring quantification
